

BY-LAW NO. 2 CARLETON CONDOMINIUM CORPORATION NO. 86

WHEREAS the members of Carleton Condominium Corporation No. 86 hereinafter called the Corporation wish to strengthen the Corporation's powers of enforcement of Rule 17, By-Law No. 1 of the Corporation relating to vehicles parking on the common elements of the Corporation;

NOW THEREFORE under the authority of the Condominium Act of Ontario as amended by O. Reg. 636/79 and amendments thereto, and of the Declaration, proper notice having been given to all members of the Corporation and all mortgagees entered on the Register of the Condominium, be it enacted as By-Law No. 2 of Carleton Condominium Corporation No 86 as follows:

"In addition to any remedies or liens provided by the Act, if any automobile is found to be parked on the common elements of the Corporation otherwise than in accordance with the then existing parking regulations, the Corporation may remove that automobile from the common elements of Carleton Condominium Corporation No. 86 at the expense of the owner of that automobile."

CARLETON CONDOMINIUM CORPORATION NO. 86

BY-LAW NO. 3

Be it enacted as By-law No. 3 (being a By-Law respecting additions to the common elements) of Carleton Condominium Corporation No. 86 (hereinafter referred to as the "Corporation") as follows:

Whereas a number of unit owners in the Corporation have expressed a desire to make certain additions, alterations, or improvements, or alternatively, have already made such additions, alterations, or improvements, to the common elements enjoyed by the particular unit owner;

And whereas the Corporation has no objection to the alterations, additions or improvements listed in Article III below (herein called "additions") provided that each addition is or has been carried out in accordance with plans, drawings, specifications and colours approved by the Corporation and provided the particular unit owner (and his successors) assumes all responsibility (on his or her own behalf and on behalf of his or her successors and assigns) for maintenance, repair, insurance, liability and any other costs or expenses associated with any addition made by the particular unit owner (subject to the terms of this By-Law);

And whereas Section 39 of the <u>Condominium Act</u> (herein called "the Act") requires that additions, alterations or improvements to the common elements which are not substantial receive the approval of unit owners owning a majority of units for which owners are in attendance at a meeting;

And whereas the Corporation has determined that none of the additions are substantial;

And whereas Section 28 of the <u>Condominium Act</u> requires that By-Laws be confirmed by owners who own not less than 51 percent of the units;

And whereas the Corporation has therefore duly called a meeting of unit owners to be held on _______, for the following purposes, namely;

- (a) to obtain the required unit owner approval to allow unit owners to carry out the additions subject to the terms and conditions as listed in Article IV below;
- (b) to confirm this By-Law, which confirmation will also serve as evidence of the approval described in (a) above;

Now therefore be it enacted as a By-Law of the Corporation as follows:

ARTICLE I DEFINITIONS

All words used herein which are defined in the Condominium Act, R.S.O. 1980, c.84, shall have ascribed to them the meanings set out in the Act as amended from time to time.

ARTICLE II APPROVAL

The confirmation of this By-Law in accordance with s.28 of the Act constitutes approval for unit owners to carry out the additions described in Article III hereof, and also constitutes retroactive approval for those unit owners who have already carried out such additions, subject to the terms and conditions set forth in Article IV hereof, all in accordance with Section 38 of the Act, and the Declaration of the Corporation.

ARTICLE III

Unit owners may make any one or more of the following additions or alterations to the common elements, subject in each case to the terms and conditions set forth in Article IV hereof;

- (1) Replacement of windows;
- (2) Installation of central air conditioning (not watercooled), with central air conditioning units installed in exclusive-use rear yard;
- (3) Up-grading of exterior doors (as opposed to simple replacement of the door with a door of similar quality, as a necessary repair measure);
- (4) Installation of gates in exclusive-use rear yards;
- (5) Installation of storm doors or screen doors.

ARTICLE IV TERMS AND CONDITIONS

The within approval of the additions or alterations ("additions") described in Article III is subject to the following terms and conditions and any unit owner carrying out, or having carried out, any such addition agrees with the Corporation and all other unit owners, on his/her own behalf and on behalf of his/her successors and assigns, to be bound by and to comply with all such terms and conditions, namely:

- (1) No addition shall be made except in accordance with a set of standard plans, drawings, specifications and colours approved by the Corporation or as otherwise specifically approved in writing by the Corporation;
- (2) All additions shall comply with all municipal, provincial and federal legislation including all municipal By-Laws and building regulations;
- (3) Each addition shall be maintained and repaired in a good and safe condition by the unit owner at the unit owner's sole expense (except for gates in the exclusive-use rear yards which shall be maintained by the Corporation). Notwithstanding the provisions of the Act and Declaration and By-Laws of the Corporation, the Corporation shall not be responsible to maintain or repair any addition (except for maintenance of the gates, as aforesaid) nor shall the Corporation be responsible to retain any insurance with respect to any addition;
- (4) In the event that the unit owner fails to maintain or repair the addition as required herein, the Corporation may, at its option and after notifying the unit owner of the said failure and affording the unit owner a reasonable opportunity to effect such maintenance or repair, carry out such maintenance or repair and all costs and expenses incurred by the Corporation in arranging and carrying out the maintenance or repair

shall be payable to the Corporation by the unit owner;

- (5) The unit owner shall obtain insurance, satisfactory to the Corporation, against any and all liability which may arise in connection with the addition. The unit owner shall provide to the Corporation proof satisfactory to the Corporation that such insurance is in place within a reasonable period of time following any request by the Corporation for such proof.
- (6) The unit owner shall fully and completely indemnify and save harmless the Corporation from any and all loss, costs, expenses, claims or damages, of whatever kind and however arising, as a result of the breach of any of these terms and conditions, or otherwise relating to the addition, including any claims against the Corporation for damages resulting from, caused by, or associated with the addition;
- (7) Any amounts owing to the Corporation by a unit owner by virtue of these terms and conditions shall be added to the unit owner's common expenses and shall be collectible against the unit owner in the same manner as common expenses;
- (8) In addition to any other rights and remedies available to the Corporation hereunder or otherwise, in the event that any unit owner contravenes any of the within terms and conditions, the Corporation shall be entitled, upon ten days written notice to the unit owner, to remove the addition and restore the common elements to their previous condition. All costs and expenses associated with such removal and restoration shall be the responsibility of the unit owner and shall be payable by the unit owner to the Corporation;
- (9) Any such addition carried out by a unit owner shall be carried out at the unit owner's expense (except for gates in the exclusive-use rear yards, for which the unit owner will pay the cost of materials only);
- (10) All of these terms and conditions shall be binding upon the successors and assigns of the unit owner;
- (11) All of these terms and conditions shall similarly apply to any addition carried out prior to the enactment of this by-law;

ARTICLE V MISCELLANEOUS

- (1) <u>Invalidity</u>: The invalidity of any part of this By-Law shall not impair or affect in any manner the validity and enforceability or effect of the balance thereof.
- (2) <u>Gender</u>: The use of the masculine gender in this By-Law shall be deemed to include the feminine and neuter genders and the use of the singular shall be deemed to include plural wherever the context so requires, and vice versa.
- (3) Walver: No restriction, condition, obligation or provision contained in this By-Law shall be deemed to have been abrogated or waived by reason of any failure to enforce the same irrespective of the number of violations or breaches thereof which may occur.
- (4) Headings: The headings in the body of this By-Law form no part thereof but shall be deemed to be inserted for convenience of reference only.

BY-LAW NO. 4

BE IT ENACTED as By-law No. 4 (being a Borrowing By-law) of Carleton Condominium Corporation No. 86 (hereinafter referred to as the "Corporation") as follows:

WHEREAS the owners in the Condominium have been given the option to participate in a "Window Upgrade Program", at their cost;

AND WHEREAS the Corporation has agreed to assist owners (who opt to participate), by offering them financing for the Window Upgrade Program (payable on agreed terms by the participating owners who accept the Corporation's financing offer);

AND WHEREAS the Corporation wishes to raise some or all of the required funds for this purpose by way of borrowing as set forth herein;

AND WHEREAS the said borrowing requires approval by By-law.

NOW THEREFORE, be it enacted as By-law No. 4 of the Corporation as follows:

ARTICLE I DEFINITIONS

All words used herein which are defined in the Condominium Act, R.S.O. 1990, c. C-26, or any successor (the "Act") shall have ascribed to them the meanings set out in the Act as amended from time to time.

ARTICLE II BORROWING

- (1) The Corporation is hereby authorized to borrow funds for the purposes described above, in an amount and on terms acceptable to the Board ("the loan"), subject to a borrowing limit of \$100,000.00.
- (2) All of the costs of borrowing shall be payable by those owners who accept the Corporation's offer of financing, in accordance with the terms of that offer. All other owners are released from any obligation under the loan.
- (3) All payments hereunder form part of the common expenses of the unit owners responsible for the particular payments, and are recoverable as such.
- (4) Default in Payment:
 - (a) Arrears of any payments required to be made to the Corporation under the provisions of this Article or under the provisions of the Condominium Act shall bear interest at the rate under the loan.
 - (b) In addition to any remedies or liens provided by the Act, if any owner is in default in payment for a period of fifteen (15) days, the Board may retain a

solicitor on behalf of the Corporation to enforce collection and there shall be added to any amount found due all costs of such solicitor as between a solicitor and his own client and such costs may be collectible against the defaulting owner in the same manner as common expenses.

- (c) All payments upon account of arrears shall be first applied to interest and then to the assessment arrears which were first due with respect to the particular unit.
- (5) In the event that the Corporation receives or delivers any notice for the calling of a meeting to consider the termination of the Condominium or any notice respecting an application to the Supreme Court for an Order terminating the Condominium or any other manner of notice or application with respect to the termination of the Condominium, the Corporation shall forthwith register Notices of Lien under the seal of the Corporation, in the form prescribed, against all units not released from the loan.

ARTICLE III MISCELLANEOUS

- Invalidity: The invalidity of any part of this By-law shall not impair or affect in any manner the validity and enforceability or effect of the balance thereof.
- Gender: The use of the masculine gender in this By-law shall be deemed to include the feminine and neuter genders and the use of the singular shall be deemed to include plural wherever the context so requires, and vice versa.
- 3. <u>Waiver:</u> No restriction, condition, obligation or provision contained in this By-law shall be deemed to have been abrogated or waived by reason of any failure to enforce the same irrespective of the number of violations or breaches thereof which may occur.
- 4. <u>Headings:</u> The headings in the body of this By-law form no part thereof but shall be deemed to be inserted for convenience of reference only.
- 5. <u>Alterations:</u> This By-law or any part thereof may be varied, altered or repealed by a By-law passed in accordance with the provisions of the Act, and the Declaration.

The foregoing By-Law is hereby passed by the Directors and confirmed by the owners pursuant to the *Condominium Act* of Ontario.

BY-LAW NO. 5

BE IT ENACTED as By-law No. 5 (being a Borrowing By-law) of Carleton Condominium Corporation No. 86 (hereinafter referred to as the "Corporation") as follows:

WHEREAS the Corporation wishes to carry out certain repairs to the common elements consisting primarily of siding replacement;

AND WHEREAS the Corporation wishes to raise some of the required funds to complete the work by way of borrowing as set forth in this by-law;

AND WHEREAS By-law No. 1, Article V.2(g) of the Corporation authorize the Board to borrow amounts required to carry out the objects and duties of the Corporation, including the obligation to complete the repairs described above, subject to authorization of the owners;

NOW THEREFORE, be it enacted as By-law No. 5 of the Corporation as follows:

ARTICLE I DEFINITIONS

All words used herein which are defined in the Condominium Act, R.S.O. 1990, c. C-26, or any successor (the "Act") shall have ascribed to them the meanings set out in the Act as amended from time to time.

ARTICLE II BORROWING

- (1) The Corporation is hereby authorized to borrow funds for the purposes described above, in an amount and on terms acceptable to the Board ("the loan"), subject to a borrowing limit of \$125,000.00.
- (2) All payments hereunder form part of the common expenses of the unit owners responsible for the particular payments, and are recoverable as such.

(3) Default in Payment:

BE IT ENACTED as By-Law No. 6 (being a by-law respecting insurance deductibles) of Carleton Condominium Corporation No. 86 (hereinafter referred to as the "Corporation") as follows:

ARTICLE I. DEFINITIONS

All words used herein which are defined in the Condominium Act, 1998, or any successor, ("the Act") shall have ascribed to them the meanings set out in the Act as amended from time to time.

ARTICLE II. SECTION 105(3) OF THE ACT

This by-law is passed pursuant to Section 105(3) of the Act, to extend the circumstances under which a deductible loss, as described in Article III, shall be added to the common expenses payable for an owner's unit.

ARTICLE III. INSURANCE DEDUCTIBLES

- (1) Property insurance for the units and common elements (excluding improvements) is obtained and maintained by the Corporation (the "Master Policy"), but is subject to a loss deductible clause.
- (2) The Master Policy accordingly does not cover any loss, or portion of a loss, falling within such deductible. Responsibility for any such loss shall be determined as follows:
 - (a) Any deductible loss relating to damage to a unit (whether or not there has been an act or omission by the owner or lessee of the unit) shall be the responsibility of the owner of the unit, and shall be added to the common expenses payable for the owner's unit [in accordance with Article III (4)].
 - (b) Any other deductible loss shall be the responsibility of the Corporation.
- (3) Notwithstanding the foregoing,
 - (a) each unit owner shall indemnify and save harmless the Corporation and all other owners from any deductible loss (under the Master Policy) related to damage resulting from an act or omission of the owner, or his or her guests, agents or occupants of the unit. (Accordingly, if any such damage is caused to any part of the property, any related deductible loss under the Master Policy shall be added to the common expenses payable for the owner's unit, in accordance with Article III(4)).
 - (b) the Corporation shall indemnify and save harmless each unit owner from any deductible loss resulting from an act or omission of the Corporation or its directors, officers, agents or employees.
- (4) Any amounts owing to the Corporation by a unit owner by virtue of the terms of this bylaw shall be added to the common expenses payable by such unit owner and shall be collectible as such, including by way of condominium lien.

- Each owner shall obtain and maintain insurance, including personal liability insurance, (5) covering the owners' risks as set forth in this by-law.
- The Corporation shall promptly provide written notice of any change in the deductible (6)related to the Master Policy to all owners.

ARTICLE IV. **MISCELLANEOUS**

- The invalidity of any part of this by-law shall not impair or affect in any Invalidity: (7) manner the validity and enforceability or effect of the balance hereof.
- No restriction, condition, obligation or provision contained in this by-law (8) shall be deemed to have been abrogated or waived by reason of any failure to enforce the same irrespective of the number of violations or breaches thereof which may occur.
- The headings in the body of this by-law form no part thereof but shall be (9) deemed to be inserted for convenience of reference only.
- Alterations: This by-law or any part thereof may be varied, altered or repealed by a bylaw passed in accordance with the provisions of the Act, and the Declaration.

The foregoing by-law is hereby passed by the Directors and confirmed by the owners pursuant to the Condominium Act, 1998, of Ontario.

BY-LAW NO. 7

BE IT ENACTED as By-Law No. 7 (being a by-law respecting common element modifications) of CARLETON CONDOMINIUM CORPORATION NO. 86 (hereinafter referred to as the "Corporation") as follows:

ARTICLE I. DEFINITIONS

All words used herein which are defined in the Condominium Act, 1998, as amended, or any successor thereto (the "Act"), shall have ascribed to them the meanings as set out in the Act.

ARTICLE II. PURPOSE OF THIS BY-LAW

This bylaw is being passed for the following purposes:

- 1. To confirm the types of common element modifications which owners are permitted to make, subject to the terms and conditions described in this by-law.
- To record the Board's approval of the modifications, subject to the terms and conditions in this by-law.
- To provide any required notice to owners and required voting approval for the modifications.
- 4. To establish the terms and conditions which apply to any such modifications and which accordingly constitute an agreement between the owner(s) and the Corporation pursuant to the Act and this by-law.

ARTICLE III. PERMITTED MODIFICATIONS

- 1. Unit owners may make any one or more of the following modifications to the common elements, subject in each case to the terms and conditions set forth in Article IV hereof:
 - a. Exclusive use patio areas constructed of patio stones.
 - b. Flower gardens in front yard arrears adjacent to the unit.
 - c. Flower boxes outside of exclusive use yard areas.
 - d. Municipal address numbers.
 - e. Installation of storm doors or screen doors (Note: if the board amends the approved entrance door from wood to steel, as anticipated by the Reserve Fund Study, storm doors will be discouraged).
 - f. Decks in exclusive use yard areas.
 - g. Interlocking stone walkways or patios.
 - h. Landscaping including planting of bushes and trees which may grow taller than 6 feet, in exclusive use yard areas.
 - i. Vents for high efficiency gas furnaces or other appliances.
 - j. Unit resident name sign.
 - k. External natural gas outlets for a barbeque.
 - 1. Physical aids for the disabled.
 - m. Composters in exclusive use areas.
 - n. Satellite dishes.
 - o. Window air conditioners.
 - p. Utility sheds in exclusive use yard areas.
 - q. Additional attic insulation.

- r. Additional exterior hand rails for front steps.
- s. Installation of gates in exclusive-use rear yards.
- t. Installation of central air conditioning (not water-cooled), with central air conditioning units installed in exclusive-use rear yard.
- 2. In addition to the foregoing, owners may make any one or more of the following modifications to the common elements, subject to the terms and conditions set forth in Article IV hereof:
 - a. Upgrading of exterior doors prior to scheduled replacement by the Corporation. The approved standard replacement door at the date of this by-law is a solid core wood slab door. The corporation will undertake replacement of all exterior doors at some future date, in accordance with recommendations made in the Reserve Fund Study. In anticipation of the door replacement program, the Corporation may amend the standard approved entrance door to require steel entrance doors in accordance with recommendations made in the Reserve Fund Study. If an Owner chooses to upgrade his or her entrance door prior to scheduled replacement of entrance doors by the Corporation then he or she shall undertake such replacement on the understanding that:
 - (i) There may be no credit for the cost of the replacement door against any increase in common expenses or special assessment that may be levied to undertake replacement of entrance doors generally. (Any credit that may be given would have to be confirmed in writing, by the Corporation, at the time that the Owner applies for approval to undertake the upgrade or replacement).
 - (ii) Owners who upgrade their doors with a wood slab door do so on the understanding that the specifications for the approved standard door may change and knowing that the door that they install may be replaced a second time, without credit to them, as part of any door replacement program undertaken by the corporation.
 - b. Upgrading of windows. For the purpose of this provision, Owners acknowledge the replacement and upgrading of all windows is the responsibility of the unit owner and is undertaken at the sole expense of the owner. As such, Owners have flexibility with respect to the timing of window replacement and may undertake replacement of existing windows with windows of the approved standard specification, provided that they do so at their sole expense and subject to board approval of the proposed installation in accordance with Article IV.

ARTICLE IV TERMS AND CONDITIONS

The within approval of the modifications described in Article III (herein called the "modification(s)") is subject to the following terms and conditions and any unit owner carrying out, or having carried out, any such modification(s) agrees with the Corporation and all other unit owners, on his/her own behalf and on behalf of his/her successors and assigns, to be bound by and to comply with all such terms and conditions, namely:

- No modification shall be made or kept except with the prior written approval of the Corporation, such approval not to be unreasonably withheld. The modification shall comply with all plans, drawings, specifications, colours and/or other requirements as may be approved in writing by the Board or as may be set forth in the By-laws, Rules or Policies of the Corporation. Furthermore, prior to proceeding with the modification, the owner shall obtain and provide to the Corporation such permits and professional certificates as may be requested by the Board.
- 2. All modifications shall comply with all municipal, provincial and federal legislation, including all municipal By-Laws and building regulations. The owner shall investigate and determine all occupational health and safety requirements that apply to any work related to the modification (including work related to installation, repair or maintenance of the modification) and shall ensure that all of those requirements are met.

- 3. Except as otherwise provided in Article IV (5) each modification shall be maintained and repaired in a good and safe condition by the owner at the owner's sole expense. The Corporation shall not be responsible to maintain or repair the modification, nor shall the Corporation be responsible to obtain any insurance with respect to the modification. The modification shall be at the sole risk and expense of the owner and the modification shall be owned by the owner.
- 4. In the event that the owner fails to maintain or repair the modification as required herein, the Corporation may, at its option and after notifying the owner and affording the owner a reasonable opportunity to effect such maintenance or repair, carry out such maintenance or repair and all costs and expenses incurred by the Corporation in arranging and carrying out the maintenance or repair shall be payable to the Corporation by the owner and shall be collectible in accordance with Article IV(8) hereof.
- 5. The Corporation shall maintain and repair the following modifications after the unit owner has completed the modification itself:
 - a. Optional replacement or retro-fitting of windows;
 - b. Up-grading of exterior doors;
 - c. Installation of gates.
- 6. The owner shall obtain insurance against any and all risks of damage or harm to persons or property or any other liability which may arise in connection with the modification. The owner shall provide to the Corporation proof satisfactory to the Corporation that such insurance is in place within a reasonable period of time following any request by the Corporation for such proof.
- 7. Subject to the cost of maintenance and repair to be performed by the Corporation pursuant to Article IV(5), the owner shall fully and completely indemnify and save harmless the Corporation from and against any and all loss, costs, expenses, claims or damages, of whatever kind and however arising, as a result of a breach of any of these terms and conditions, or otherwise relating to the modification, including any claims against the Corporation for damages resulting from, caused by, or associated with the modification. Without limiting the generality of the foregoing, the owner shall be responsible for all costs and expenses incurred in order to remove the modification to afford the Corporation access to any portion of the property (for the purposes of carrying out repair or maintenance, or for any other reason) as well as reinstatement of the modification (if desired), and the Corporation shall have no obligation for any damage which may be caused to the modification as a result of any such required access.
- 8. Any amounts owing to the Corporation by the owner as a result of these terms and conditions shall be added to the owner's common expenses and shall be collectible against the owner, together with all reasonable costs, charges and expenses incurred by the Corporation in connection with the collection or attempted collections of the amount, in the same manner as common expenses, including by way of Condominium lien in accordance with the Condominium Act.
- 9. In addition to any other rights and remedies available to the Corporation hereunder or otherwise, in the event that the owner contravenes any of the within terms and conditions, the Corporation shall be entitled, upon ten days written notice to the owner, to remove the modification and to restore the common elements to their previous condition. All costs and expenses associated with such removal and restoration shall be the responsibility of the owner and shall be payable by the owner to the Corporation, and collectible in accordance with Article IV(8) hereof.
- 10. The modification shall be carried out at the sole risk and expense of the owner.
- Any notice required hereunder may be delivered as set out in the by-laws of the corporation.
- All of these terms and conditions shall be binding upon the successors, assigns and transferees of the owner.

NOTES:

- Any other modifications to the common elements not listed herein may require separate approval by a vote of the unit owners in accordance with the Act, and the Declaration.
- The Corporation may carry out changes to the common elements provided it complies with the requirements in the Act.

ARTICLE IV. ACKNOWLEDGEMENT

Any owner wishing to carry out a Modification after May 5, 2001 shall sign an Acknowledgement in the form attached as Schedule "1". The Acknowledgement shall be held by the Corporation in the owner's unit file and the Corporation shall attach a copy of the Acknowledgement to any status certificate issued regarding the unit.

ARTICLE V. PREVIOUS BY-LAWS OR RULES

Where any provision in this by-law is inconsistent with the provisions of any previous by-law or Rule, the provisions of this by-law shall prevail and the previous by-law or Rule shall be deemed to be amended accordingly. Where a modification had approval prior to the enactment of this by-law, pursuant to a rule respecting modifications to the common elements, such modification is continued under the provisions of this by-law and the modification shall be governed by this by-law.

ARTICLE VI. MISCELLANEOUS

- Invalidity: The invalidity of any part of this by-law shall not impair or affect in any manner the validity and enforceability or effect of the balance thereof.
- 2. <u>Waiver</u>: No restriction, condition, obligation or provision contained in this by-law shall be deemed to have been abrogated or waived by reason of any failure to enforce the same irrespective of the number of violations or breaches thereof which may occur.
- Headings: The headings in the body of this by-law form no part thereof but shall be deemed to be inserted for convenience of reference only.
- 4. <u>Alterations</u>: This by-law or any part thereof may be varied, altered or repealed by a by-law passed in accordance with the provisions of the Act, and the Declaration.

The foregoing by-law is hereby passed by the Directors and confirmed by the owners pursuant to the Condominium Act, 1998 of Ontario.

By-Law No. 8

BE IT ENACTED as By-Law No. 8 (being a Borrowing By-Law) of CARLETON CONDOMINIUM CORPORATION NO. 86 (hereinafter referred to as the "Corporation") as follows:

WHEREAS the Corporation is required to carry out certain work, namely: paving work ("the work");

AND WHEREAS the Corporation wishes to raise some or all of the required funds for the work by way of borrowing as set forth herein;

AND WHEREAS paragraph 56(1)(e) of the *Condominium Act, 1998* allows the Corporation to borrow amounts required to carry out the objects and duties of the Corporation, subject to the prior authorization by by-law;

NOW THEREFORE be it enacted as a By-Law of the Corporation as follows:

Article I Definitions

All words used herein which are defined in the *Condominium Act, 1998*, and the regulations thereunder, as amended, ("the Act") shall have ascribed to them the meanings set out in the Act as amended from time to time.

Article II Borrowing

- The Corporation is hereby authorized to borrow funds, on terms acceptable to the Board, for the purpose of carrying out the Work and paying expenses directly related to the Work, subject to a maximum borrowing limit of \$250,000.00 (TWO HUNDRED AND FIFTY THOUSAND DOLLARS) ("the loan").
- All payments under the loan shall be included as part of the common expenses, and shall be collectible as such in accordance with the provisions of the Act and the Corporation's Declaration.

Article III Miscellaneous

- 1. **Invalidity:** The invalidity of any part of this By-Law shall not impair or affect in any manner the validity and enforceability or effect of the balance thereof.
- Waiver: No restrictions, conditions, obligations or provisions contained in this By-Law shall be deemed to have been abrogated or waived by reason of any failure to enforce the same irrespective of the number of violations or breaches thereof which may occur.
- Headings: The headings in the body of this By-Law form no part thereof but shall be deemed to be inserted for convenience of reference only.
- 4. Alterations: This By-Law or any part thereof may be varied, altered or repealed by a By-Law passed in accordance with the provisions of the Act and the Declaration.

The foregoing By-Law is hereby passed by the Directors and confirmed by the owners pursuant to the *Condominium Act of Ontario*.
